



2018 SPENCER COUNTY FARM BUREAU SCHOLARSHIP PROGRAM APPLICATION

Spencer County Farm Bureau will award three **\$2,000** scholarships for the current school year. One \$2,000 scholarship will be awarded to a high school senior pursuing a degree at a college/university. The second \$2,000 scholarship will be awarded to a high school senior attending a vocational/technical institute. The third \$2,000 scholarship will be awarded to a student currently attending a college/university or a vocational/technical institute. Scholarship monies can be applied to tuition, housing, books, etc. Payments are made in two equal payments to the school upon proof of enrollment. Preference will be given to students who major in agriculture or a related field of study.

To be eligible, applicants must:

- have a minimum 2.5 cumulative GPA (on a 4.0 scale).
- be the child of a Spencer County Farm Bureau member family. Family must have been a member during the previous year in 2017, a current member in 2018 and remain such while the scholarship is in force.
- be a current resident of Spencer County.
- for the current college/university or vocational/technical institute scholarship, the student must be currently enrolled in a college/university or a vocational/technical institute.

RULES

- Recipient must attend either a college/university or a vocational/technical institute.
- Recipient must enter the college/university or vocational/technical institute no later than the fall semester once the scholarship has been awarded.
- Applications must be postmarked no later than **March 30, 2018**. Completed applications should be mailed to:

- Applicants will be judged by an out-of-county awards committee.
- The awards committee will make the final determination on all cases concerning the interpretation of these rules. All applications become the property of the Spencer County Farm Bureau and will not be returned.
- Winners will be notified by April 30, 2018. Students will receive their scholarship payment once proof of enrollment has been provided to Spencer County Farm Bureau.
